

Registration for the wingwave training

Conditions of Registration and Terms

Reservation, Payment Methods, Implementation Agreement

- 1. The training fee is 1800 Euro plus VAT
- 2. Upon receipt of the respective invoice payment must be made only by bank transfer to the account specified in the invoice. Please indicate name, invoice number, seminar name and seminar date. For payments from abroad please note the additional transfer fees that may be incurred for international transfers. We do not accept cash or debit card payments. If you cancel after the registration we will, after receipt of a written notice of cancellation, collect the following fee:
- up to 30 days before the event: 30.00 € booking fee
- to 15 days before the event: 50% of the fee
- thereafter, the entire fee will be charged.
- 3. We refer to the possibility of cancellation insurance. These services aren't offered by the organizers themselves. This may be taken up with external service providers.
- 4. The right of withdrawal for consumers does not apply because the event is exclusively a business to business transaction.
- 5. If an advertised training coach is prevented from attending with good cause, this is no reason for a cancellation providing that the organizer provides another trainer in their place who is qualified to the same level.
- 6. Should the course be cancelled for an important reason by the organizer, for example due to illness or force majeure (e.g. Corona Virus), the possible amount already paid will be refunded immediately. Other claims cannot be asserted.
- 7. The organizer reserves the right to change the event for good reason (e.g. insufficient number of participants) to another equivalent venue within the place of the training.
- 8. By registering, the participant agrees that the photos or film footage taken during the event may be published on the internet or used for advertising purposes.
- 9. Audio and video and photo recordings



Video, photo and audio recordings of the seminar may only be made by the participants with the prior consent of the Besser-Siegmund-Institut. Private photos may be taken as long as this does not interfere with the course of the seminar. The publication of the photographs electronically, in print media and/or all other media requires the permission of the Besser-Siegmund-Institut. The legally prescribed rights to one's own image must be observed. In seminars, photo, video and audio recordings are sometimes made by the employees of the Besser-Siegmund-Institut or a person authorized by them to do so. By participating in the seminar, the participant gives his/her consent to the private and commercial use of these recordings. The training participant gives his consent that the training group photo may be used for advertising purposes in the social networks of the Besser-Siegmund-Institut. A claim to commission or other payments is fundamentally excluded, unless otherwise agreed in writing in advance. If the internet quality of online events is reduced due to circumstances for which the organizer is not responsible (disruptions on the internet and/or technical disruptions of the platforms involved), the full seminar price must still be paid.

- 10. wingwave is fundamentally an additional intervention tool for appropriately certified Coaches, Trainers, Doctors and Therapists. It does not replace the qualification to become a Coach or Therapist.
- 11. Participation requires normal mental and physical capacity. The training participant is already a certified Wingwave-Coach with a valid contract.
